#### **CALL TO ORDER**

#### **APPROVAL OF CURRENT FINANCIAL REPORT**

President Furnell reported a balance of \$32,926.12 in Business Checking account, Balance of \$25,026.48 in Capital Expenditures Savings account. Dawn Fowler made a motion to approve the financial report; motion seconded by Karen Ward and passed unanimously.

#### FINAL CALL TO SUBMIT BALLOTS

There was one enveloped received with lot# 'whited out' that was not counted. There was one envelope "returned to sender' (mailed to Rapton) that was not counted Homeowners deemed ineligible to vote due to non-payment of dues:

Monigold (Lot 48) and Tolbert (Lot 35) President Furnell asked those present for an impartial person to assist Cheryl in the counting of the ballots; Steve Ziegler volunteered.

# DISCUSSION OF PAST AND ONGOING PROJECTS

President Furnell reported on community projects consisting of beach improvements, Street maintenance by T&C (to be reviewed in the Fall) and signs added.

The beach received a load of new sand, there were signs added stating 'Private Property, No Trespassing", and the ramp gate was sanded and repainted by Karen, Vallyn, and Kit. One street sign was added regarding unlicensed vehicles and drivers being prohibited. There continues to be an issue with unleashed dogs.

Karen announced that Cheryl Shockley is resigning from her duties effective this date; she is willing to continue the bookkeeping duties and has a prepared proposal for the new board should they choose to accept it.

# DISCUSSION AND COMMENTS FROM HOMEOWNERS

Agenda item requested for the next regular meeting is discussion of CCR's progress. Dawn Fowler has been rewriting the CCRs and is very near completion. John Mihelich asked to see a copy of what has been done so far. He was assured by President Furnell that a copy of the draft will be distributed to the homeowners for their comments and concerns when they are ready. Mike Lotka asked if the draft would be reviewed by a legal firm. President Furnell responded yes, that the final draft would be given to an Arizona attorney specializing in Homeowners Association CCRs, but that the board wanted to have input from the members first, and submit a final draft to an attorney, to avoid extra expenditures for legal fees.

Ryan Johnson requested discussion on short term rentals and their use of the community beach and parking issues.

Mary Goehring asked about sweet sweeping; President Furnell responded that the sweeper comes from Lake Havasu, quarterly, and that we do not have a choice of the type of equipment they bring.

Jamie Lynch reported that Homeowner John Monigold (Lot 48) had recently passed away. Karen Ward discussed beach wall plans and ideas to shore up the seawall to make it safer. President Furnell stated that when the water was down in January 2021, Mike Dyer and Chris Chambers assessed the seawall and both agreed it was in good shape, the footing was deep and holding, The issue is the extra cement at the base that is dangerous to step on while on the sand area.
